MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (hereinafter referred to as MOU) is by and between **K.L Mehta Dayanand College for Women, Faridabad**, hereinafter referred to as "College" and **Avadna Services Pvt. Ltd** (hereinafter referred to as "Luneblaze") a **Startup** recognized by DPIIT, Government of India.

This MOU is effective on the date of the last signature by the authorized officials of the two parties.

Article 1 – BASIC UNDERSTANDING

Luneblaze is a Knowledge-Sharing network which facilitates online as well as physical interactions for Knowledge-Sharing and Learning purposes. We believe that Physical interactions are the most significant interactions and have a long-lasting impression on us.

At Luneblaze, we are connecting students of all the institutions by providing them with a platform where they can learn whatever they want to learn and can share what others want to learn, in this way, helping each other by creating a healthy learning environment. They can interact with like-minded students of other Colleges can form teams for projects, exams and discussions.

Till date we have signed MoUs with **15+ Colleges**, organized **300+ sessions** in which approximately **7000+ students** have participated in institutions like JC Bose College of Science and Technology, Alfalah University, MVN University, DCTM, Echelon Institute Of Technology, Advanced College, DAV Centenary College, DAVIM, Pt. LR College Of Engineering etc. on almost all Academic streams i.e. Engineering, Management, Commerce, Pure Science, Personality Development, Entrepreneurship and Art.

Article 2 – OBLIGATIONS OF LUNEBLAZE

2.1 Luneblaze will list the institution on Luneblaze Platform/App by creating a **Page of the College**. It will contain information about the institution like the courses it provides, website link of the institution, Google Map Location and venue photos. It also contains information about the Number of Luneblaze Sessions organized in the institution, Ratings by the attendees and the information about the Venue team as well.

2.2 Any student of the College who is registered on the Luneblaze Platform and attend status is TRUE, can participate in any Knowledge Sharing Session.

2.3 Luneblaze will be forming a team of 10-20 students in your College which would be responsible for collecting demands from the students and managing the sessions. These students will be provided with benefits like assured internships & will be our first preference for hiring. However, a representative will also come from Luneblaze, who will be monitoring all the things and will guide the team members for smooth functioning of Session.

2.4 Luneblaze Sessions are sponsored sessions in which we introduce and thank our sponsors.

2.5 Students of College can attend sessions taking place in the College for **FREE**.

2.6 We will introduce **50 Corporate** in the college for placements which will entertain only the students having conducted a certain number of minimum sessions.

2.7 The above obligations from Luneblaze are completely **FREE**.

Article 3 – OBLIGATIONS OF THE COLLEGE

3.1 Any Luneblaze registered user with a valid Legal ID and who is engaged in a particular session, will be allowed to enter the institution for Knowledge Sharing purpose.

3.2 Once a Session is finalised at the institute at a time specified by the College, the Institution will provide necessary requisites required to conduct a session like:

- Chairs and Tables
- White Board and marker

- Ventilation
- Sanitation
- Drinking Water

3.3 Luneblaze Sessions will be organized only in the time allowed by the College. College needs to provide minimum 6 hours per week, with slot minimum 2 hours. Below are the week days along with time committed, if there is any change in the committed hours, College shall inform Luneblaze a week before:

3.4 Luneblaze will not be liable to pay any amount to the college for the above obligations.

Article 4 – DURATION AND TERMINATION OF MOU

4.1 Duration of MOU: The MOU shall remain in effect for one year from the date of signing.

4.2 Mutual Termination: Circumstances may arise in which both parties wish to terminate their performance of the MOU.

4.3 Non-Mutual Termination: Circumstances may arise when one of the parties seeks to terminate the MOU. Either party may terminate this MOU for cause without the agreement of the other in that case:

- **4.3.1** If the Institution wishes to terminate the MOU, it shall advise LUNEBLAZE in writing to COMPANY CONTACT ADDRESS or to the official email.
- **4.3.2** If LUNEBLAZE wishes to terminate the MOU, it shall advise the Institution in Writing to Concerned **K.L Mehta Dayanand College for Women, Faridabad** or to the official email.


4.4 Within 10 days after receipt of a request from either party for termination of the MOU, the other party will provide an appropriate written response. The two parties shall agree upon the termination conditions, including the effective date (which shall be 10 days after the two parties agree to termination). In no event shall LUNEBLAZE be liable for any cost or charge actually incurred after the effective date of termination.

Article 5 - GENERAL

5.1 This MOU constitutes the entire and only MOU between the parties, and all prior negotiations, representations, agreements, and understandings are hereby superseded. No agreements altering or supplementing the terms hereof may be made except by means of a written document signed by the duly authorized representatives of the parties.

5.2 Any notices required by this MOU shall be given by prepaid, first class, certified mail, return receipt requested, addressed in the case of the Institution: Industry Relationship Officer, **K.L Mehta Dayanand College for Women, Faridabad.**

5.3 This MOU shall be governed by, construed, and enforced in accordance with the internal laws of the state of Haryana. IN WITNESS WHEREOF, the parties have executed this agreement effective as of the day and year indicated by the last signature below.
