MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (hereinafter referred to as MOU) is by and between K L Mehta Dayanand College For Women hereinafter referred to as "College" and Avadna Services Private Limited (hereinafter referred to as "Luneblaze").

Article 1 - BASIC UNDERSTANDING

2.4 College Portal:

The College will be listed on the Luneblaze Platform where college can update relevant information about the college. College can use the Platform to organize Quizzes, Debates and Sessions for the students and could use the Platform as a Marketing tool.

2.5 Platform for Overall Development of Students:

Luneblaze helps students in learning their domain skills, by providing them with a platform where they can learn through Collaboration by engaging in activities like Quizzes, and Debates with students of other colleges as well and Luneblaze Sessions helps the students in developing their Soft-Skills leading to the overall development of the students.

2.6 Luneblaze Operations:

Luneblaze will be forming a team of 10-20 students in your College which would be responsible for collecting demands from the students and managing the sessions. However, a representative will also come from Luneblaze, who will be monitoring all the things and will guide the team members for the smooth functioning of the Sessions and Placements Drives.

Article 3 - OBLIGATIONS OF THE COLLEGE

- Sanitation

3.3 Luneblaze Sessions and Campus Drives will be organized only in the time allowed by the

which students can take part in Sessions and Campus Drives. Below are the weekdays along with
time allowed for Luneblaze:

3.4 Luneblaze will not be liable to pay any amount to the college for the above obligations.

Article 4 - DURATION AND TERMINATION OF MOU

- 4.1 Duration of MOU: The MOU shall remain in effect for one year from the date of signing.
- **4.2 Mutual Termination**: Circumstances may arise in which both parties wish to terminate their performance of the MOU. In this case, Luneblaze will not be liable for any payment.
- **4.3 Non-Mutual Termination**: Circumstances may arise when one of the parties seeks to terminate the MOU. Either party may terminate this MOU for cause without the agreement of the other in that case:
 - 4.3.1 If the College wishes to terminate the MOU, it shall advise LUNEBLAZE in writing to COMPANY CONTACT ADDRESS or to the official email.
 - **4.3.2** If LUNEBLAZE wishes to terminate the MOU, it shall advise the College in writing to the concerned authority of the college in the official email.
- **4.4** Within 10 days after receipt of a request from either party for termination of the MOU, the other party will provide an appropriate written response. The two parties shall agree upon the termination conditions, including the effective date (which shall be 10 days after the two parties agree to termination).

Article 5 - GENERAL

5.1 This MOU constitutes the entire and only MOU between the parties, and all prior negotiations, representations, agreements, and understandings are hereby superseded. No agreements altering or supplementing the terms hereof may be made except by means of a written document signed by the duly authorized representatives of the parties.

5.2 Any notices required by this MOU shall be given by prepaid, first-class, return receipt requested, addressed in the case of the College: Industry Relationship Officer.

5.3 This MOU shall be governed by, construed, and enforced in accordance with the internal laws of the state of Haryana. IN WITNESS WHEREOF, the parties have executed this agreement effective as of the day and year indicated by the last signature below.
