About the College

Established in the year 1970, K.L. Mehta Dayanand College for Women situated in the heart of city of Faridabad providing quality holistic higher education to aspirants. The college has got B++ NAAC grade in its 3rd Cycle of NAAC accredited in June 2022. At present 122 faculty members along with 12 nonteaching staff members are catering to the needs of 3796 (approx.) students enrolled in ten UG programmes and six PG programmes across Arts, Science Commerce and Management, Computer Science and Home science faculty respectively. Teaching-learning ecosystem in the institution, comprising various practices and programmes has immense potential and provides ample opportunities to the students to horn their skills. The institution has a well inbuilt mechanism for organising co-curricular and extra-curricular activities and this provides wider scope of experiential learning. The sprawling campus 5.5 acres with well-ventilated 59 classrooms, fully-equipped Science labs, Computer labs, spacious Multi-purpose Hall and Seminar hall. The library is having good stock of books with Web-OPAC facility.
