Asian Hospital, Badkal Road, Faridabad and K.L. Mehta Dayanand College for Women-Faridabad are linked by training, students' visits, hands on experiments, research and innovation interests and seek to develop collaborations and exchanges in fields of shared interest and expertise. The activities undertaken pursuant to this Linkage are based on a spirit of cooperation and reciprocity that is intended to be of mutual benefit to both parties.

1. Purpose

This Linkage serves as a written understanding of agreed upon principles between Asian Hospital Faridabad and Faculty of K.L. Mehta Dayanand for Women-Faridabad, Haryana (India), concerning a set of general research, training and innovation objectives.

This is a non-binding agreement and is intended to clarify the nature and extent of the complementary activities that might be undertaken for the mutual benefit of the two parties. Each institution will be responsible for managing its own costs.

Commitments of specific institutional resources, personnel, space, facilities, or any other academic or intellectual activities may be contemplated here under but are beyond the scope of this Linkage.

To extent that implementation of any agreed upon activity requires a commitment of resources. A supplementary agreement must be negotiated and approved by the two parties before work on any of the projects can commence.

2. Objectives, Scope, and Major Activities

Asian Hospital, Faridabad and K. L. Mehta Dayanand College for Women, Faridabad agree to encourage the development of the following types of activities:

- Visits by students for informal exchange of ideas and interaction, exposure and experiential learning in specific areas of interest.
- Explore the possibilities for developing any internship programme resulting into their future career prospects.

3. Responsibilities of the Parties

The two parties recognize that the implementation of any agreed upon activity will depend upon the interest and expertise of the individuals involved and the availability of financial resources, space and other resources. It is further expected that both parties will be compliance with all applicable State and federal laws and regulations and University policies.

4. Duration and Option to Amend, Extend or Terminate

This Linkage will become effective when signed by both parties. The agreement will remain in effect for one year from the signature date, below, and may be renewed or amended by mutual agreement of the parties. The parties agree to periodically review the activities undertaken and the progress made and to consult concerning amendments, renewal or termination of this Linkage. Either party may terminate this Linkage at any time by providing written notice of such termination to the other party.

5. General Terms

This Linkage is not intended to, and does not create any right benefit, or trust responsibility substantive or procedural, enforceable at law or equity, by either party, its officers, employees, or agents against the other party, its officers, employees, or agents.

Nothing in this Linkage obligates either party to commit or transfer any funds, assets, or other resources in support of projects or activities between the two parties.

Neither party will use the name of the other, either expressly or by implication, in any publicity, solicitation or advertisement without the express written approval of the other party to this Linkage.

6. Signatures

This LINKAGE shall enter into force on the date of the signing by qualified representatives of both institutions.
