K.L. Mehta Dayanand College for Women-Faridabad, Haryana and District Football Association, Faridabad , Haryana are linked by training, coaching of sports students, visits, hands on experience,s and seek to develop collaborations and exchanges in fields of shared interest and expertise. The activities undertaken pursuant to this Linkage are based on a spirit of cooperation and reciprocity that is intended to be of mutual benefit to both parties.

1. Purpose

This Linkage serves as a written understanding of agreed upon principles between District Football Association, Faridabad and Faculty of K.L. Mehta Dayanand for Women-Faridabad, Haryana (India), concerning a set of general training, coaching and empowering girls students.

This is a non-binding agreement and is intended to clarify the nature and extent of the complementary activities that might be undertaken for the mutual benefit of the two parties. Each institution will be responsible for managing its own costs.

Commitments of specific institutional resources, personnel, space, facilities, or any other academic or intellectual activities may be contemplated here under but are beyond the scope of this Linkage.

To extent that implementation of any agreed upon activity requires a commitment of resources mobilization. A supplementary agreement must be negotiated and approved by the two parties before work on any of the projects can commence.

2. Objectives, Scope, and Major Activities

Both institutions agree to encourage the development of the following types of activities:

- Visits of students for fostering physical education specifically for Football Game for girls who are interested.
- Training and coaching of students for experiential learning in specific areas of interest.

3. Responsibilities of the Parties

The two parties recognize that the implementation of any agreed upon activity will depend upon the interests and expertise of the individuals involved and the availability of financial resources, space and other resources. It is further expected that both parties will be compliant with all applicable State and federal laws and regulations and University policies.

4. Duration and Option to Amend, Extend or Terminate

This Linkage will become effective when signed by both parties. The agreement will remain in effect for one year from the signature date, below, and may be renewed or amended by mutual agreement of the parties. The parties agree to periodically review the activities undertaken and the progress made and to consult concerning amendments, renewal or termination of this Linkage. Either party may terminate this Linkage at any time by providing written notice of such termination to the other party.

5. General Terms


