

MEMORANDUM OF UNDERSTANDING (MoU)

This Memorandum of Understanding (MoU) is made on 25 Sept. 2025, by and between:

GTT Foundation, having its registered Institute at **NIT-1, Faridabad**.

AND

KL Mehta Dayanand College for Women, located at NIT-3, BK Chowk Faridabad.

Purpose

The purpose of this MoU is to establish a collaborative framework under which GTT Foundation Institute will conduct **Skill Development Training Programs** at **KL Mehta Dayanand College for Women** at **free of cost**, for a period of **one year (including Training & Placement Assistance)**. These classes aim to enhance employability and professional skills among the students of the college.

Roles and Responsibilities

GTT Foundation shall:

- Conduct training programs related to skill development in fields such as Soft Skills/ Hotel-Management/Electrical/Personality Development/Interview Preparedness etc.
- Provide qualified trainers and training materials/resources.
- Ensure frequent/alternative sessions are conducted.
- Monitor progress and provide feedback to the students and college administration.
- Issue participation/completion certificates to eligible students at the end of the program.
- Upon completion, we will provide placement assistance to the students.

KL Mehta Dayanand Women College shall:

- Provide suitable classroom/training space, basic infrastructure, and necessary equipment for the sessions.
- Coordinate with students to ensure adequate participation and attendance.
- Extend administrative support to ensure smooth execution of the training.
- Facilitate communication between the trainers and college staff.

Duration

This MoU shall be effective from 25 Sept. 2025 and shall remain in effect for a period of one year, ending on 25 Sept 2025, unless terminated earlier by either Party as per the termination clause.

Financial Terms

Termination

Either Party may terminate this MoU by providing **15 days' written notice** to the other Party. Upon termination, both Parties shall ensure that no obligations remain outstanding.

Amendment

Any modifications or amendments to this MoU must be made in writing and duly signed by authorized representatives of both Parties.

Dispute Resolution

Any disputes arising out of this MoU shall be resolved amicably through mutual consultation. This MoU is not legally binding but reflects the intention of both Parties to work collaboratively in good faith.

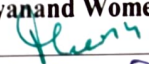
Miscellaneous
