Both the party of 'First Party' and the party of 'Second Party' shall be collectively referred to as the Parties.

OBJECTIVES

MRDC will provide the following:

1. Screening of oral diseases in students, faculty and staff.

2. Education regarding oral hygiene and proper brushing techniques.

3. Education regarding importance of proper diet and nutrition on oral health.

4. Basic dental treatment like cleaning of teeth, silver amalgam filling, tooth-coloured

filling and non-surgical removal of teeth (except wisdom teeth) will be provided free

of cost.

5. These comprehensive dental benefits and facilities will also be provided to faculty and

staff of K.L. Mehta Dayanand College for Women, Faridabad.

6. Based on requirement, provision of free pick and drop bus shuttle service once weekly

to and fro from K.L. Mehta Dayanand College for Women, Faridabad for patients

requiring dental treatment.

7. To cooperate on any other activities that may be identified on a consensual basis as

and when such an opportunity arises.

Contributions from K.L. Mehta Dayanand College for Women, Faridabad:

1. Space for provision of dental screening and health education activities.

2. Implementing joint health education training programmes

3. Ensure active participation of students and faculty in the organized

activities/programmes.

4. To ensure smooth operation of the oral health programme.

5. Cooperating on any other mutually agreed-upon activities as opportunities arise.

promotion of oral health and education within the community, fostering a healthier and well-

informed society.
