



Memorandum Between Two Parties

This Memorandum of Understanding (MOU) is signed on 6th June 2022 at New Delhi between:

Shrijaa Welfare Society is a registered society represented by Rtn. Dr Nidhi Aggarwal, Chairperson, whose registered office is at Hn.1199,Sector15, Faridabad 121007 referred hereinafter Shrijaa, Email: shrijaaventure@gmail.com (which expression shall, unless excluded by or repugnant to the context or meaning hereof, mean and include the Trustees, office bearers, representatives, administrators, executors, successors-in-title, successors-in-interest, nominees and assigns) of the FIRST PART;

AND

Rotary International represented by Club/Association K.L Mehta Dayanand College for Women (which expression shall, unless excluded by or repugnant to the context or meaning hereof, mean and include the relevant District Team members, office bearers, representatives, administrators, executors, successors-in-title, successors-in-interest, nominees and assigns) of the SECOND PART;

WHEREAS Shrijaa Welfare Society as a society / trust aims to provide the female students with a very trending and modern skillset that will enable them to aim for self-employment as well as enhancing their talents. The course curriculum designed by Shrijaa welfare Society is expected to create opportunities for skilled candidates to improve self-grooming or a career of being a beautician and / or for the purpose of self-grooming. Shrijaa had been looking for partners and to forge alliances with social / educational institutions to make their mission a reality.

AND WHEREAS based on discussions with the Shrijaa Welfare Society and the K.L Mehta Dayanand College present MOU is being executed in relation to the project 'Skill Development' referred hereinafter as **Project Shrijaa** across, to develop a detailed plan to engage Rotary supported Skill Centre networks to scale up their subsidized training and increase the number of employable and trained manpower to achieve sustainability at scale.

The Parties have decided to reduce their discussion and understanding in writing by way of execution of this MOU with the following agreed terms:





- Shrijaa has developed a Multicentre model of running skill development programs across K.L Mehta Dayanand College for Women through the Rotary Clubs who are desirous of participating in this program. The model envisages that the Rotary Clubs will support the selected/newly established centres, for the purpose of achieving skill development and employability of intended beneficiaries, especially those from the poor and needy background.
- 2. Shrijaa shall certificate courses and / or organise special workshops either directly or in association with experts from the field. Through these courses/workshop the women shall learn basic & advance makeup
- 3. The Rotary Club or Social / Educational association will provide empty space/ room measuring not less than 200 sq.ft. which will be solely used for running training as well as a temporary parlour. Shrijaa will do feasibility study of the proposed location & grant clearance to start the centre if location is found suitable. Club or association will bear the initial setup cost which may vary between 1-1.50 lac according to the space & size of the venture.
- 4. The initial more than 60 of usable cosmetics which the centre will use for daily routine will provided by Shrijaa for free of cost (25-50k), for first course whose duration will be for 3 months. The Rotary Club or Social / Educational association shall bear the cost of subsequent consumables. It is recommended that centres procure materials from subsequent months from Shrijaa to maintain quality / consistency, and thereby to justify the image of institutions associated with the project. Shrijaa will provide the teacher & the salary will be provided by association. Teacher salary would be between (6 k to 10 k.)
- 5. The entire effort of developing new centre and managing it shall be made by Shrijaa with the support of clubs. Shrijaa will enter into a separate MOU with the respective clubs for each such centre with detailed terms and conditions as mutually agreed between Shrijaa and respective Rotary Clubs.
- 6. The K.L Mehta Dayanand College for Women or any of its office bearer shall have no financial or legal responsibility towards any such centre whatsoever. Shrijaa shall keep the K.L Mehta Dayanand College for Women and / or its office bearers against any claims / liabilities etc. Shrijaa and respective Rotary Clubs pursuing this project would be responsible to ensure that the Rotary image remains upheld at all times and any branding of Rotary is depicted as per Rotary International norms.





- 7. Shrijaa team will directly coordinate with the respective partner Rotary Clubs and the Skill Development Centre to make the same functional. The Clubs will assign a one-point contact for the same.
- 8. This MOU shall be governed by the laws of India.
- 9. If any conflict or dispute of any nature arises out of or relating to or in connection with any of the points stated in the MOU, the parties shall use all reasonable endeavours to resolve the matter amicably through negotiation and subsequently by way of mediation.
- 10. The parties confirm the understanding in this agreement by duly signing in the space provided below in the presences of below mentioned witnesses:
