

Memorandum of Understanding

This Memorandum of Understanding (hereinafter MOU) has been signed between;

Zamit India (P) Ltd, having its registered office at 629-631 (6th Floor), Park Centra, Sector-30, Gurugram, Haryana-122001, India, (herein referred to as Zamit).

AND

K L Mehta Dayanand College for Women, having its address at BK Chowk, New Industrial Twp 3, New Industrial Township, Faridabad, Haryana 121001, India (herein referred to as College).

This MOU records the understanding between the Parties as below:

- 1. Programmes to be implemented:
 - 1.1. GETS Placement for registered Students:
 - 1.1.1. Computer-delivered with certificate.
- 2. Implementation Plan: The Programme will be implemented as below:
 - 2.1. GETS Assessment:
 - 2.1.1. Assessment under Point 1.1.1. will take place on 6th March 2024.
- 3. Responsibilities of Zamit: Zamit will be responsible for the following:
 - 3.1. Provide Online platform for Computer-delivered GETS Assessments with certificate.
- 4. Responsibilities of the College: The School will be responsible for the following:
 - 4.1. Nominate a Coordinator to act as the SPOC (Single Point of Contact) for Zamit
 - 4.2. Appoint teachers to help in administering GETS Assessment.
 - 4.3. Pay the fee to Zamit for the GETS <u>within 15 working days</u> of receipt of proforma invoice from Zamit.
- 5. Financial Arrangement: The College and Zamit agree on the financial arrangements as below:
 - 5.1. The Special inaugural Price of the GETS Assessment is 375/- per student (for minimum 150 students).
 - 5.2. Once the Student data is shared by the college Zamit will raise a PI of the total amount based on the above.
 - 5.3. On receiving the P.I. the college will write a mail to The Future Foundation to sponsor the amount i.e. 375/- per student as per PI (Zamit will share the format of the mail with the school)
 - 5.4. The College will pay 100% of the 'Institutional Grant from The Future Foundation' within 7 days of receiving the same from The Future Foundation.
